If you have a box, the following minimum dimensions should apply (please note our requirements under "Accommodation"):
The ceiling height = 1.5 x height at the withers (WH) Example: The foal will reach an estimated 1.60 m height.
-> 1.5 x 1.60 m = 2.40 m (at best, however, over 3 m) - This is a minimum dimension! Does this measure apply?

The box size = $(2 \times WH)^2$ (at least double the WH squared per horse) Example: The horse is 1.65 m. Tall.
-> $2 \times 1.65 \text{ m} = 3.30 \text{ m}$ -> $3.30 \text{ m} \times 3.30 \text{ m} = \sim 11 \text{ m}^2$. The interplay between the box and the roaming area is important.
A horse sleeps best lying down. This means that the lying area in the example should be 11 m² if the horse sleeps in the box overnight and has no way of leaving it.

The minimum area for free movement = 2 x box size
For example: $\rightarrow 2 \times (2 \times WH)^2 \rightarrow 2 \times 1.65 \text{ m} = 3.30 \text{ m} \rightarrow 3.30 \text{ m} \times 3.30 \text{ m} = 10.89 \text{ m}^2 \rightarrow 2 \times 10.89 \text{ m}^2 = \sim 22 \text{ m}^2$ Is the size correct?

Written consent in accordance with the General Data Protection Regulation – DS-GVO

On May 25, 2018, the new EU General Data Protection Regulation (DS-GVO) came into force with the aim of making the processing of personal data more transparent for you.

The personal data collected in the completed information, in particular name, address, telephone number, the e-mail address and living conditions for the animal serve the purposes of implementing the resulting animal takeover contract relationship and / or the resulting animal care contract relationship, tax law requirements (such as storage obligations) and veterinary and official requirements (reporting and storage obligations).

By returning this form, you allow us to save, process and use your data. We would like to point out that access to the data you have provided is only used to convey our animals and these are only available to the voluntary employees of the association, including the association's board, the intermediaries and the site controls for pre- and post-controls as well as the tax advisor and - on request - the veterinary office responsible for the association and the Spanish and German authorities. All persons who have access to your data have committed themselves to secrecy and to comply with the provisions of the DS-GVO.

We will not pass on your personal data to third parties for advertising purposes. With your signature, the data protection declaration of consent for the takeover / adoption of an animal or for the care of an animal is transferred as part of the animal takeover contract or the animal care contract.

"I agree that Horse In Need collected, stored, processed and used my data for the above-mentioned purposes, as well as passed on or transmitted to the above-mentioned third parties. When a contract is concluded, the data must be provided in accordance with the statutory provisions of the responsible veterinary office Alhaurín according to the law of animal protection - be kept for 3 years.
